INTERNSHIP OVERVIEW The MUP/DI internship is a two-year paid internship within the UNC Drug Information Center. The internship begins the summer after the first year of pharmacy school and is flexible with early immersion experiences. Interns get hands-on involvement in formulary management while sharpening clinical skills. You'll dive into researching, interpreting, and responding to real-world drug information requests, making this internship a great way to build experience and confidence in a dynamic pharmacy environment.



Student must be able to work up to 10 hours per week; however, flexible scheduling allows for more than 10 hours per week during the summer months and between 5-10 hours per week during the school year, if desired.

#### Requirements:

Student must be available to work during the hours of operation of the DI Center, which are 8 am-4:30 pm Monday through Friday.






## Potential Internship Activities
